By ensuring that MMOG/LE is rooted in an organisation’s culture and by adopting MMOG/LE best practices across the supply chain, organisations can ensure an effective and efficient communication flow with their customers, suppliers and other trading partners.

Benefits of MMOG/LE compliancy

MMOG/LE and EDI

MMOG/LE compliance requires an EDI (electronic data interchange) system to facilitate and automate the electronic exchange of order and delivery documents between trading partners.

An EDI system is required to comply with the following MMOG/LE concepts:



Inventory barcoding

To track inventory, speed up replenishment and provide real-time visibility of inventory



Automated customer data entry

All customer data is automatically integrated into the supplier's planning system without manual intervention or the use of spreadsheets.



Electronic ordering with sub-suppliers

Sub suppliers receive electronic schedules and send back electronic advanced shipping notifications (ASNs)
